NARRATIVE: William Whitfield was issued 300 acres of land on 23 Nov 1802 in Wayne County, located "On S. side of Neuse River joining the Widow Bass and Bryant Whitfield lines on Sleepy Creek.". This was recorded in Land Patent Book 116 page 162 as Wayne County Grant # 1793. The original request for this land was entered on 20 Nov 1801 and assigned Wayne County Entry # 1031. It took 1 year exactly to issue the grant.

*Note: Grant Mentions **Needham Bass** in 1802. Our Needham was about 12. This should be the mystery Needham (brother of Andrew or Rice?)*

State of North Carolina

No 1793. Know ye that we have granted unto William Whitfield three hundred acres of land in our county of Wayne on the south side of Neuse River Beginning at a Black Oak Neeham Bass corner on the south prong of Sleep Creek and run with his line crossing said creek south ninety pole to a black oak his his corner then south twenty four East one hundred pole to his own line then with his own line West one hundred and fifty four pole to a stake in said line then north three hundred and forty pole to a stake then East one hundred and thirteen pole to a stake in a line of a pa??? granted to Samuel Herring then with said line South one hundred pole to a small pine his corner then with the giving line of said parcal (?) East one hundred and sixty pole to a stake in the South prong of Sleepy creek his own corner then with his own ine South sixty pole to Basses corner on the South side of said creek then up the various courses of said creek to the first St???? entered the 20th day of November 1801 T Hold to the said William Whitefield his heirs and assigns for ever. Dated the 23rd of November 1802

NARRATIVE: Moses Bass was issued 100 acres of land on 21 Oct 1758 in Cumberland County, located "On the Raft Swamp". This was recorded in Land Patent Book 16 page 268 as Cumberland County Grant # .

NARRATIVE: Moses Bass was issued 100 acres of land on 21 Oct 1758 in Cumberland County, located "On the raft Swamp Beg. at a white oak". This was recorded in Land Patent Book 18 page 421 as Cumberland County Grant # . The original request for this land was entered on 27 Sep 1755 and assigned Cumberland County Entry # 383. It took 3 years and 1 month to issue the grant.

NARRATIVE: Some records show that Moses Bass *might* have been issued 100 acres of land in Cumberland County, located "On E. side of Solomons Swamp", but no matching Patent was found. More research is required to determine if a Patent was actually issued. The original request for this land was entered on 19 Dec 1763.

NARRATIVE: Some records show that Rias Bass *might* have been issued 30 acres of land in Cumberland County, located "Joining his own & Mrs. Armstrong on Evans Creek", but no matching Patent was found. More research is required to determine if a Patent was actually issued. The original request for this land was entered on 04 Oct 1811 and assigned Cumberland County Entry # 2566.

NARRATIVE: Rice bass [assignee of Samuel Herring] was issued 75 acres of land on 04 Jan 1792 in Wayne County, located "Joining Wm Whitfield lines.". This was recorded in Land Patent Book 75 page 454 as Wayne County Grant # 433. The original request for this land was entered on 10 Mar 1788 and assigned Wayne County Entry # 307. It took 3 years and 10 months to issue the grant.

No 433 Know ye that we have granted unto Rice Bass seventy five Acres of land in our County of Wayne Joining William Whitfields lines Beginning in Sleepy creek in William Whitfields line at a water oak and turns South ninety five poles to a pine then West one hundred and twenty poles to a stake then North ninety five poles to a black jack then to the Beginning To hold to the said Rice Bass his heirs and assigns forever dated the 4th Jan 1792.
