Formation of relevant counties in North Carolina:

- 1696 Bath County formed as original county
- 1705 Bath County divided into Wickham, Archdale, & Pamptecough Precincts
- 1710 North Carolina and South Carolina separate Provinces
- 1712 Archdale name changed to Craven Precinct
- 1729 New Hanover Precinct formed from Craven Precinct
- 1739 All Precincts designated as Counties
- 1746 Johnston County formed from Craven County
- 1750 Duplin County formed from New Hanover
- 1758 Dobbs County formed from Johnston

- note: Eventually owned over 5000 acres in North Carolina via numerous land grants. Had land in Johnston, Dobbs and Wayne Counties. Incl: 200 acres in Duplin in 1768.
 - 475 acres, Craven County, 1737, 650 acres, Craven County, 1739, 450 acres, Craven County, 1757, 309 acres, Johnston County, 1756, 475 acres, Johnston County, 1759, 200 acres, (A.1) Duplin County, 1768
- (B) Thomas Bass (1719-1786): b: Norfolk, VA? / d: Bertie Co, NC
- (C) Thomas Bass (1740): b/d: Wayne Co, NC
- (D) Jesse Bass (1767):
- (E) Everett Bass (1774): I: Sampson Co, NC
- (F) Dr. Andrew Bass Jr (aft 1730): b: Craven Wayne or Wales, I: Waynesboro
 - Conflicting info on birthplace. Some sources say Craven Co , NC. The "Heritage of Wayne Co" states he and his wife Alice were born in Wales and came to Waynesboro before the Revolutionary War.
- (G) Andrew Bass Jr (1756-1791): b: Wayne Co, d: Wayne Co.
- (H) Andrew Bass (1778-1836): b: Wayne Co, d: Wayne Co. I: Johnston Co in 1820 and 1830 census.
- (*) Our Andrew Bass (~1730)



Land Auction of Andrew's Land (Key Landmarks)

- 1784 (180 acres of two tracks to Thomas Hooks)
- 1
- 80 of 300 acres formally belonging to Teague.
- SS (Southside) of NE Swamp (aka NE Cape Fear River).
- 2
 - 100 acres adjacent to 1st Track (1).
 - Pine by Edward Duncan's Line to a White Oak by the Bass' line.
 - To pine by Solomon's Line (Formally Draper).

1785 (125 Acres to Thomas Hooks)

- 3
 - George Kernegay's pine to dividing line between Bass-Kernegay-Duncan line.






Crimes committed by Andrew's sons, Harmon, John and Rice (Related to map)

Land is the William Teague 300 acres along the NE Cape Fear River above Rones Chapel Rd

- 1) Harmon attempted to murder George Kornegy in the woods (owned a significant amount of land near Andrew's land)
- 2) Rice, John and Abraham Davis shot two young Bearfields in their cornfield. Solomon died. Frederick eventually recovered

Thomas Hooks is who Rice and Harmon robbed "his cart". (Likely the Lieutenant section 5a1)

John and Rice attempted murder of Capt Offey Williams and Robbed Capt Blanshards and Mr. Whitefield's houses,


Rice murdered Arthur Adams

Rice and John in the company that murdered Franks, Blackshire and Boston.

Harmon (following the British out of New Bern), killed John Stevenson in front of his wife and family.


Rice stole guns and powder (at gunpoint for Uriah Blanshard)


North Carolina Populations (1729)





Early North Carolina Counties (1760)
