Note: There is no DNA or paper connection between Richard and our Andrew (1730). It is however important to detail the other Bass lines living in and around our own.

Jass THE BASS FAMILY By Edith DeShazo Nichols The family name of Bass is mentioned in the records of Esser County Leicestershire, and in Etbhlandshire, in Central and South-eastern England. It is possible that the original Bass came to England with the Norman Conquest, as the name is supposedly derived from the French word "bas", meaning short. In England Bass ale is well known, and the family owned the establishment through the centuries, until sold for ten million dollars several years ago. In 1630 three Bass brothers came to the United States and settled in New England. The first Episcopal bishop in America was Bishop Bass of Boston. Even prior to this, however, Captain Nathaniel Bass was one of the earliest settlers of Virginia, and it is from him that the Bass family in Northern Alabama is descended. Nathaniel Bass was a son of Humphery Bass, a merchant of London, England. In 1613 he married Mary Jourdan. In 1621 or 1622 he establish his "Bass's Choice" Plantation in Isle of Wight County, Virginia. His son, John Bass, married Keziah Tucker, an Indian girl. Their son, Richard Bass, was born on August 2, 1658 and died on December 26, 1722. His first wife, Jane Bryant, was born on December 17, 1665 and married on November 6, 1680. Their children were Charles, James, Matthew, Keziah, and Anna. After her death he married Mary Burwell and they had children named Andrew, Alexander, Bichard, Mary, William, Uriah, and Thomas. Most of these moved to Craven County, North Carolina, and thence to Johnston, Wayne, Duplin, and Sampson counties. The precedampxemfpryntage ding information about the Richard Bass family is from an undated certificate (possibly about 1725) signed by William Rudd, M.G. and C.L., Parish of Elizabeth River in Virginia. This certificate appears in a book "Bass Families of the South" by Dr. Albert D. Bell, copywright 1961.

William Rudd, Clergyman of the Parish of Elizabeth River Church, stated "These are peaceful subjects of His Majesty George I, King and defender of ye faith, numbered among ye Nansiemum people, freeborn, and worthy of ye respectfull consideration of Christians in ye Church in Carolina as in Virginia and intitled to the same."

Evidently the Basse family was preparing to move south to North Carolina. It was the custom to be released from one Parish so that they could transfer to the Parish church in their new area. As the above-statement was not dated, it probably pertained to the children of Richard Basse, Sr., as he died in Nansemond, Virginia, on St. Stephen's Day 26 Dec 1722.

It is son Andrew that we find later in North Carolina.

According to Bell, he had two wives, however there are court records that record his first wife being brought to court for leaving her children alone while away, this at a time when his first wife was supposed to be dear. There is also a court document showing him in a transfer of land for a tobacco crop listing his wife as a signatory giving up her dower rights on the property. I would wait a while before counting on Richard to be solid information. It may be that Richard is a correct ancestor, however there were apparently two Richards at that time and we have not been able to dig them out for a certainty. It could be that there were two richards at that time (probably related) and they were mixed up. Leah has some additional information on them but it is taking time to dig it out.

There is a controversy surrounding the marriage of Richard Basse to Mary Burwell, See below. 10 Richard Basse, seventh of the eight children of John and Elizabeth/Keziah Basse, is said to have been born in Nansemond County, Virginia, on August 2, 1658. This information comes from a certificate said to be in the possession of family members. The certificate says that Richard married Jane Bryant on November 6, 1680; that she died on February 14, 1690, having borne six children in nine years; and that Richard then married Mary Burwell on August 25, 1695 and had six more children by her. Dowd, Sylvestri, and the Nansemonds have produced court records proving that Jane Basse was still alive at least as late as 1701. They claim that the certificate is a forgery; that Richard never married Mary Burwell; and that the last four children (at least) attributed to Richard were probably grandchildren of John's brother Edward (who may also have married an Indian, but if so she was a Chowan rather than a Nansemond). something happened there. The marriage of John & Elizabeth in 1638 was most likely an arrangement between the settlement & the tribe for mutual benefit.. it offered some protection for both sides. They remained together until death. In a matrilineal society in that timeframe Elizabeth had total say over her marriage & home. They lived with the tribe as custom dictated. She didn't go live with John. After the birth of the first child the family would be considered Nansemond or FPOC.

I think you're right about the line ending except for descendants of William 1654. One male heir in addition to him would've left descendants that would have surfaced by now. The 2008 study in England was released in 2014 I think. That study was the best shot for a match.

John & Elizabeth had another son born 1658.. Richard. His ydna from marriage to Jane remained Basse R M269 L47.

Mrs. Dowd and Mrs. Silvestri, were the former editors of Southern Bass, a BASS family quarterly that was published for a little more than 4 years. They have donated these manuscripts to the Nansemond Tribe. The money raised from the sale of these manuscripts is to be used for the development of the Nansemond Indian Tribal Cultural Center.

This manuscript contains records and information which differentiate Captain Nathaniel Basse from Nathaniel Basse, son of Humphrey Basse. This manuscript is a culmination of many years of effort by several Bass descendants who joined efforts for this research. This manuscript is approximately 42 pages and contains copies of original records that were used to support their findings. It corrects some of the previously published errors about this BASSE line.

Andrew Basse Sr. seems to be the first of the Basse males to acquire considerable acreage in North Carolina. (Actually North Carolina was part of Virginia until 1737). There are many deeds pertaining to him in the Counties of Johnston, Dobbs, Jones, Lenoir, Wilson, Craven, Dublin and Pamlico and others. It is not that he or his family moved, it is that the county lines changed. The counties were named after men of great service to the state, and when the men fell into disfavor, the county name would be changed again. North Carolina has one of the most confusing county boundries, dates and names.

Andrew Basse Sr. acquired 475 acres in Craven Co. in 1737; 650 acres in 1739; 450 acres in 1757; In Johnston Co. 309 acres in 1756, 475 acres in 1759; In Dublin Co. 200 acres in 1768. (Listed under Patents granted in His Majesty's part of the Province of North Carolina, Colonial Office 5/319, London, England). The North Carolina Tax List 1763-1835 lists Andrew Basse Sr. with 5,770 acres and 12 Black slaves. 10 August 1754 Andrew Bass Sr. (note "e" in Basse now dropped) grants Power of

Attorney to Richard Blackledge (his son-in-law) in Craven County, NC 10 September 1754 Andrew Bass Sr. of Johnston Co., NC deeds gift of 225 acres to Richard Blackledge. If Richard to die, plantation to be divided between sons Richard and Andrew Bass Jr.

5 August 1765 Andrew Bass Sr. of Dobbs Co., NC sells 100 acres to Richard Blackledge of Craven Co., NC

There seems to be no mention of Andrew's wife, Elizabeth, so in all probability she had died by the time he deeded the gifts of land, stock and negroes to his children and grandchildren. Son Andrew goes on to become a "Doctor" and used the title of "Esquire" and became a prominent figure in North Carolina. (Large "Planters" and wealthy merchants affixed the title "Gentleman" or "Esquire" or "Planter" after their name.)

Andrew Bass Sr.'s will dated 22 Jan 1770 and probated in the March Court, Craven Co., NC, names son Richard Jr., Son Andrew Jr., and son-in-law Richard Blackledge "to equally divide between them and their heirs a total of 116, 5 shillings owed from other estates." Grandson URIAH BASS, Thomas Blackledge, William Blackledge to have 70 laid out for 2 young negro girls. Grandson Richard Blackledge Jr. one negro. Grandson Andrew to have land rented to give him income for an education. Also land on Gray's Branch on NE Cape Fear River in Duplin County to be sold. Executors: Son Richard Bass Jr., Son-in-law Richard Blackledge & 2 grandsons (illegible). There remain many more deeds that we have not uncovered yet pertaining to the exchange of land among the Basse/Bass family. We wonder why it is that so many tracts of land were given or sold to Richard Blackledge? However, the shares he received were in actuality, his wife Anne's. Women lost title of their property to their husbands when they married!

It would also appear that Andrew Basse Jr. (Dr.) and his wife Ann remained childless

as we never found mention of any grandchildren receiving land, negroes or feather beds, etc.

During the Revolutionary War in 1776, the Bass family split into two factions: Andrew Bass Jr. and his family heartily joined and distinguished themselves as patriots. Andrew's kinsmen Aaron Bass and his sons Moses, William, Edward, Aaron, resisted all comers, British and Patriot, and threatened to kill Governor Richard Caswell when the local militia attempted to draft them. The 3rd NC Regiment rounded up the

dissenters of the Bass Clan and arrested them.

The Fifth Provincial Congress which met at Halifax, NC on 12 November 1776 was

represented by Dobbs Co. with Richard Caswell (Ist Governmor of NC in 1777). Simon

Bright from the Kinston area (took "g it out of Kinaston because of dissention with

England and the King), Abraham Sheppard and Benjamin Exum from northern Dobbs

Co., and Andrew Bass Jr. who lived where Goldsboro,, NC now stands. (p.28 Annals of
