- [Sarah Bass](#) (45 yrs) b: 1805 (Sarah is head of house with no husband listed). She is most likely a widow of a Harmon Bass (~1800) who is likely a son of one of the Bass Brothers (Harmon, Rice, John)
- [Andrew Bass](#) (21 yrs) b: 1829 (Andrew Jackson Bass) / Laborer
- [Rice Bass](#) (19 yrs) b: 1831 / Laborer
- [John Bass](#) (16 yrs) b: 1834 / Student
- [Horman Bass](#) (12 yrs) b: 1838
- [Mathew Bass](#) (9 yrs) b: 1841
- [Sarah Bass](#) (7 yrs) b: 1843

Note: Andrew, Rice, John and Harmon were born in North Carolina.
Mathew and Sarah were born in Sumter Co, Georgia after the 1839 move.

1850 (Sarah Bass) Sumter Co, GA / 27th District / Oct 29, 1850

Sarah is believed to be the Sarah Sally (b: 1804 in NC) who married Harmon Bass (b: ~1800 in NC) (probably the son of Harmon Bass, our **Rice's** Brother)

- Andrew Jackson Bass (1829-1877) (Enlisted in Company K, Georgia 9th Infantry Regiment). Married Arretha Kersey (b. 1841) from Fayette County, Georgia.
- Uriah "Rice" Bass (1831-1897) Pvt CSA (Enlisted in Company K, Georgia 9th Infantry Regiment on 11 June 1861) Wounded in leg, necessitating amputation, at Wilderness, VA on 06 May 1864. Discharged, disability, in 1864. (Resident of Georgia since 1839.
- John Bass (1834-1861) Pvt CSA (Enlisted in Company K, Georgia 9th Infantry Regiment on 11 June 1861)
- Harmon Bass (1838-1863) Pvt CSA (Enlisted in Company K, Georgia 9th Infantry Regiment on 11 June 1861) (Killed in a wreck on Wilmington & Manchester Railroad on 02 Feb 1863)
- Mathew Bass (1841-?) Pvt CSA (Enlisted in Company K, Georgia 9th Infantry Regiment on 11 June 1861) (Wounded at 2nd Battle of Manassas, Va on 30 Aug 1862, died in a hospital in Virginia)
- Sarah Bass (1843-?)
